<b>FACTS</b>	<b>WHAT DOES APPRIZA PAY TECHNOLOGIES, LLC. ("APPRIZA PAY") DO WITH YOUR PERSONAL INFORMATION?</b>
WHY?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
WHAT?	<p>This GLBA Privacy Notice covers information you provide to us for purposes of registration with and operation of the Appriza Pay mobile app. The types of personal information we collect, and share can include:</p> <ul style="list-style-type: none"><li>• Contact Details (e.g., name, physical address, email address, and phone number)</li><li>• Financial Information (e.g., debit card and bank account information)</li><li>• Identity Verification (e.g., SSN, passport information)</li></ul> <p>Information you provide to us that is not within the scope of this GLBA Privacy Notice is instead subject to our <a href="#">Privacy Policy</a></p> <p>Information you provide to any of our partners for purposes of the financial transactions and services they provide to you fall under their privacy notices and, if shared with us, are subject to the terms of those notices.</p>
HOW?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Appriza Pay chooses to share; and whether you can limit this sharing.

<b>What we do</b>	
How does Appriza Pay protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. For more information, visit <a href="#">Terms of Use</a> .
How does Appriza Pay collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> <li>• Register with us and use our app</li> <li>• make a remittance transfer through one of our partners using our app</li> <li>• open an account or obtain a debit card with one of our partners using our app</li> </ul> <p>Information provided for the use of our partners falls under their privacy notices; we receive and use that information only to perform the transactions you have requested unless those partners are permitted to share the information with us for our marketing purposes (subject to any opt-in or opt-out rights set out in those notices). We also collect your personal information from others, such as credit bureaus, affiliates or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>• sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>• affiliates from using your information to market to you</li> <li>• sharing for nonaffiliates to market to you</li> </ul>

<b>Definitions</b>	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"><li>• Our affiliates include companies with an Appriza Pay name</li></ul>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"><li>• Nonaffiliates with whom we may share can include (i) other financial services companies (including other financial institutions, such as banks) that provide services made available through our Appriza Pay app; and (ii) non-financial service providers such as hosting platforms, KYC/AML and fraud protection vendors, sanctions screening vendors, data processors, marketing partners, and API integrators.</li></ul>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

<b>OTHER IMPORTANT INFORMATION</b>	
<p>We will comply with applicable state privacy laws:</p> <p><b>California, Connecticut, North Dakota and Vermont Residents:</b> We will not share your information with companies outside of Appriza Pay and our affiliates, except for our everyday business purposes, for marketing our products and services to you, or with your consent. We will not disclose credit information about you within or outside Appriza Pay except as required or permitted by law.</p> <p><b>Additional Information collected.</b> The only other personal information we receive is analytics information relating to internet or network activity and geolocation. That information is subject to our separate <a href="#">Privacy Policy</a> and does not fall within the scope of this GLBA Privacy Notice.</p> <p><b>Business transfers.</b> In the event of a merger, dissolution, reorganization, or similar corporate event, or the sale of all or substantially all of our assets, (including, in each case, any due diligence relating thereto), we expect that the information that we have collected, including personal information, would be transferred to the surviving entity in a merger or the acquiring entity. All such transfers shall be subject to our commitments with respect to the privacy and confidentiality of such personal information as set forth in this GLBA Privacy Notice.</p>
